## Annexure - Class 6 (FD&D) Rule Changes for the 2021/2022 Policy Year

Proposed Class 6 (FD&D) Rule Changes are set out below.

The proposed changes are set out below with additional wording underlined. The words ~~struck~~

~~though~~ are to be removed from the text of the existing Rules.

Amend Rule 26 as follows:

### **RULE 26          Exclusion of Risks Covered by Protection and Indemnity Policies**

The Association shall not insure a Member to any extent whatsoever against any cost for which the Member would be insured if the Entered Ship were fully insured under P&I Policies on terms not less wide than those of Class 3 - Protection and Indemnity - of the Association current at the time when the claim arises and with no deductible or franchise applicable to claims under those policies or could be insured subject to the exercise of a discretion contained therein.

**EXPLANATION:**          This amendment makes it clear that costs that may be covered under P&I policies on a discretionary basis are excluded from cover under Class 6 (FD&D).

### **RULE 34          CESSER OF SHIP ENTRY**

Amend Rule 34(4) as follows:

**Ship    34(4)** If the Ship shall be missing for ten days from the date it ~~she~~  
**Missing**          was last heard of or from it ~~her~~ being posted at Lloyd's as missing, whichever shall be the earlier.

**EXPLANATION:** This amendment is made in order to modernise the wording used in reference to a ship.
