DETERMINATION OF THE LOCATION OF CERTAIN AREAS IN WATERS OUTSIDE THE REGIONS OF
WORKING ENVIRONMENT AND IN THE AREA OF ENVIRONMENT OF PORT INTEREST
FUNCTIONING FOR ANCHOR ACTIVITIES IN TANJUNG BERAKIT WATERS, RIAU ISLANDS
PROVINCE

BY THE GRACE OF GOD ALMIGHTY
MINISTER OF TRANSPORTATION OF THE REPUBLIC OF INDONESIA

Considering

- a. that in the framework of developing the location of the water area for anchoring activities in accordance with the Marine Spatial Planning of the Riau Islands Province in the Zoning Plan for Coastal Areas and Small Islands (RZWP3K), in the waters of Tanjung Berakit, Riau Islands Province is designated as a location for anchoring activities;
- b. that in accordance with Article 101 of the Regulation of the Minister of Transportation Number 51 of 2015 concerning the Operation of Seaports, the determination of the location of certain areas in waters outside the Working Environment Area and the Port Interest Area that functions as a port is determined by the Minister;
- c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate a Decree of the Minister of Transportation concerning the Determination of the Location of Certain Areas in Waters Outside the Region Of Work Environment and Areas of Port Interest that Serves for Anchoring Activities in the waters of Tanjung Berakit, Riau island Province

DECIDE:

To stipulate DECREE OF THE MINISTER OF TRANSPORTATION CONCERNING DETERMINATION OF THE LOCATION OF CERTAIN AREAS IN WATERS OUTSIDE THE REGIONS OF WORKING ENVIRONMENT AND IN THE AREA OF ENVIRONMENT OF PORT INTEREST FUNCTIONING FOR ANCHOR ACTIVITIES IN TANJUNG BERAKIT WATERS, RIAU ISLANDS PROVINCE

FIRST: Determine the location of certain areas in waters outside the area of working environment and the area of port interest in the waters of Tanjung Berakit, Riau Islands Province, for anchoring activities at the following coordinate points:

1. Area A
 - a) 01° 21' 36.894" N - 104° 36' 46.402' E
 - b) 01° 20' 58.505" N - 104° 41' 24.261" E
 - c) 01° 21' 43.522" N - 104° 44' 52.138" E
 - d) 01° 21' 39.494" N - 104° 47' 14.788" E
 - e) 01° 24' 38.183" N - 104° 49' 04.054" E
 - f) 01° 30' 41.168" N - 104° 44' 04.705" E
 - g) 01° 24' 31.790" N - 104° 41' 07.238" E

2. Area B

- a) 01° 13' 59.330" N - 104° 40' 24.903" E
- b) 01° 10' 56.476" N - 104° 45' 22.240" E
- c) 01° 06' 38.764" N - 104° 51' 28.029" E
- d) 01° 05' 51.714" N - 104° 51' 08.777" E
- e) 01° 10' 35.090" N - 104° 41' 05.546" E
- f) 01° 12' 09.191" N - 104° 39' 35.703" E

SECOND: Service Users who will carry out activities in certain territorial locations in waters outside the work environment and port interest areas in Tanjung Berakit waters, Riau Islands Province as referred to in the FIRST Dictum are required to:

- a. comply with laws and regulations in the field of ports, sea transport traffic, shipping safety and protection of the maritime environment;
- b. pay attention to the interests and comply with regulations from other government agencies related to the activities carried out;
- c. settle service fees in accordance with the provisions of the applicable laws and regulations;
- d. be responsible for the impacts that arise as a result of the activities carried out;
- e. report activities in the anchorage area regularly to the Head of the Tanjung Uban Class I Port Operator Unit Office.

THIRD: Service Users in carrying out activities of anchoring in certain territorial locations in waters outside the work environment and port interest areas in the waters of Tanjung Berakit, Riau Archipelago Province are prohibited from:

- a. carry out activities outside the boundaries of the waters for activities in the specified anchorage area;
- b. dispose of waste into the waters;
- c. carry out activities outside the scope of activities specified in the anchorage area in accordance with the provisions of the legislation.

FOURTH: The Director General of Sea Transportation carries out technical guidance and supervision of the implementation of this Ministerial Decree.

FIFTH: This Ministerial Decree shall come into force on the date of stipulation.
