MACN'S ANONYMOUS INCIDENT REPORTING SYSTEM ENABLES MARITIME PLAYERS TO SUBMIT REPORTS ON CORRUPT DEMANDS THEY HAVE FACED DURING PORT OPERATION. TO DATE, MACN HAS COLLECTED MORE THAN 50,000 REPORTS OF CORRUPT DEMANDS GLOBALLY.

# MACN SPRING MEETING

## **APRIL 2023**

MACN WELCOMED OVER 150 PARTICIPANTS AT THE SPRING MEMBERS MEETING, HELD AT MOLTKES PALÆ IN COPENHAGEN ON APRIL 26 - 27 2023. THE MEETING COVERED A MIX OF PLENARY SESSIONS AND WORKSHOPS.

#### **COUNTRY WORKSHOPS**

Country workshops were held between members and MACN's local partners with key highlights including:

- Egypt an update on MACN activities undertaken with the Suez Canal Authorities, followed by members sharing their canal transit experience over the last 6 months
- India updates on MACN's work in India including HelpDesk success stories and government support highlights
- Indonesia members discussed key challenges and mapped out

areas where MACN should focus its collective action initiative. Updated guidelines on port entry procedures and port tariffs were presented

- Nigeria collective action developments, including a focus on the process and impact of the HelpDesk
- West Africa in this expansion workshop, members mapped challenges and gaps in West African countries with the goal to help MACN prioritise and further solidify our collective action efforts.

#### INDUSTRY AND ANTI-CORRUPTION COMPLIANCE WORKSHOPS

The workshops were based around challenges faced by different industry working groups. In the P&I Club industry working group Members shared insights on how MACN can support insurance and P&I clubs in collective action countries. The discussion focused on implementation of the upcoming correspondents' anti-corruption training and challenges faced by P&I clubs and correspondents.

There was also an interactive workshop covering how anticorruption compliance can be operationalised including implementing a company's Anti-Bribery-Corruption policy onboard, easing the process of incident reporting and discussions around the corruption risks during the maritime recruitment phase.

#### KEY GOVERNANCE DECISIONS

The MACN Chair, Ann Shazell, announced that the Board is recruiting new members to the MACN Board with Dorte Rolff, Brendon Hawley and Kevin Leach Smith leaving the Board after the Members Meeting in September 2023. Members can nominate themselves or another member via macn@macn.dk.

The strategy will work towards an overall 2030 goal that the maritime industry will no longer regard corruption as an obstacle to maritime trade and key ambitions include:

- 1. Scaling MACN's industry footprint
- 2. Broadening MACN's scope and mandate to tackle corruption challenges in maritime trade and hinterland transport
- 3. Deepening MACN's value proposition to members and partners

To achieve the 2030 ambitions, MACN has formulated the following targets that will enable the transformation it is seeking to achieve:

- Grow and diversify MACN's revenue and funding base
- Strengthen MACN's organisational resources and local capacity.

The importance of anti-corruption is highlighted in SDG 16 (Peace, Justice and Strong Institution). Corruption is a major obstacle to sustainable development and a threat to countries stability, individuals lives and their livelihoods.

MACN's work connects to multiple SDGs. However, **the importance of anti-corruption is explicitly highlighted in SDG 16 (Peace, Justice, and Strong Institutions)**, and through its setup, MACN is a strong example of SDG 17 (Partnerships for the Goals). MACN has mapped its activities to the relevant reporting frameworks such as the Global Reporting Initiative (GRI) and Sustainability Accounting Standard Board (SASB).

## MACN ANNUAL REPORT 2022

In July MACN published their 2022 Annual Report. Over the last 18 months, the world has moved out of a pandemic-driven mindset, handled the ongoing war in Ukraine, and worked through major shifts in the economic and trade landscape. Issues of governance, including a focus on anti-corruption, have increased in prominence at the foreign policy, regulatory, and corporate levels.

For MACN, this has led to continued growth in their membership and an increase in demand for frontline support and company compliance tools. The organisation has seen anti-corruption trends impact their work in several important ways.
