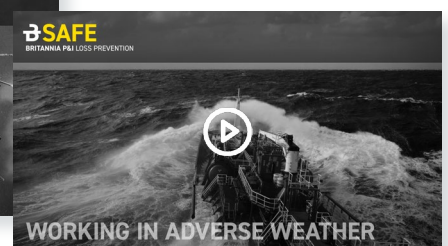
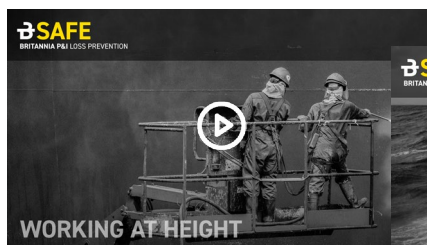
SAFETY VIDEOS

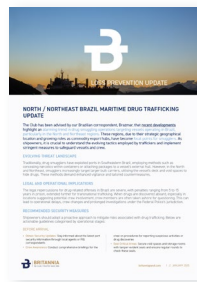

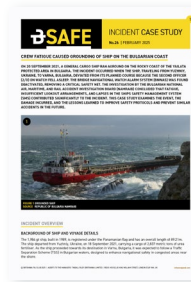
